- 3) To organise the Community engagement programme.

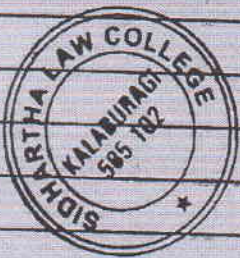
Proceeding :-




