IQAC Co-ordinator welcomed all members & read agenda.

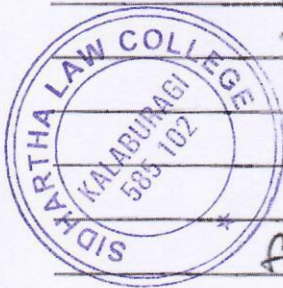
- ① First agenda: last meeting ~~present~~ discuss and how much these recommendation of IQAC cell had been implemented.
